MOVEMENT DOCUMENTS

The appropriate movement document must accompany the sheep to the market and be handed over to a market official at the loading banks. All sheep to be unloaded at sheep loading banks.

EID TAGGING

ALL SHEEP MUST BE DOUBLE TAGGED WITH AN EID TAG AND CONVENTIONAL TAG. Trading Standards Officials will be in attendance carrying out checks.

Vendors & Purchasers are responsible for checking their data on the SCOTEID database at for maintaining accurate and complete records of their sheep in accordance with the relevant regulations.

SAWDUST

A dusting of sawdust will be applied to pens prior to sale, weather permitting.
